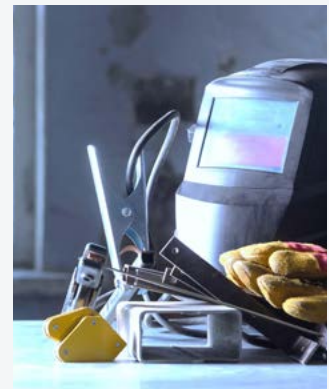

Eligibility & Deadlines

The application period is open from April 1 to March 31 each year. You must be receiving a NYS paycheck at the time you apply and belong to one of the following CSEA-represented bargaining units:

- Administrative Services Unit /02
- Operational Services Unit /03
- Institutional Services Unit /04
- Division of Military and Naval Affairs /47



Get Targeted Tuition Benefits up to \$2,500 Each Year

When enrolling in one of these eligible training programs, you can choose from our 140+ participating education providers that accept Partnership tuition vouchers, or attend another accredited school and receive reimbursement. You can also choose one of each.

We will only approve requests for providers that are accredited educational institutions.

Vouchers

Choose vouchers to pay tuition upfront at one of our participating education providers.

Reimbursement

Choose reimbursement to reclaim pre-paid tuition at another accredited education provider, upon course completion.

Remaining balances will not carry over to the next program year. Any tuition costs above the maximum provided will be your responsibility. All other expenses are also your responsibility, such as fees, books, and materials.

Combine Your Standard and Targeted Benefits

Our tuition benefits program allows you to combine benefits for even greater savings.

You may combine your standard benefits (\$5,000) and targeted benefits (\$2,500) up to a maximum of \$7,500.

You also have access to an **unlimited** number of eligible certification/licensure exams and credit-by-exams, up to \$350 per exam.

! Tax Considerations

If employer-sponsored benefits from the Partnership alone, or in combination with educational/tuition assistance from other NYS employer-sponsored benefits add up to more than \$5,250, you will have taxes taken out of your State paycheck(s) in December. For details, it's best to talk to your accountant or tax advisor. They can give you personalized advice based on your situation.
